



**COLLABORATIVE PARTNERSHIP AGREEMENT  
BETWEEN

Janardan Rai Nagar Rajasthan Vidyapeeth (JRNRV)**

**Parties**

The parties to this COLLABORATIVE PARTNERSHIP are:

- Al-Shamal Private University SPU, Sarmada, Idleb, Syria.
- Janardan Rai Nagar Rajasthan Vidyapeeth, Udaipur, India.

**1. Purpose**

- 1.1 The broad objectives of this PARTNERSHIP are to promote cultural, educational and scholarly exchange; collaboration and technical interchange between the parties involved in this agreement.
- 1.2 Upon the mutual consent of the parties, including the relevant academic management within the universities; collaboration may be carried out in, but not necessarily limited to, the following activities:
  - Joint studies by academic, technical and administrative staff.
  - Exchange of materials in education and research, publications and academic information.
  - Facilitate and conclude the articulation of courses at or between the two universities.
  - Collaborative research and publication.
  - Joint marketing and promoting for institutions
  - Joint organization of conferences, seminars or other academic meetings.
  - Joint organization of technical training or administrative programs.
  - Joint development and delivery of courses and programs.
  - Joint courses that can be delivered online.
  - Exchange of scholarships and mutual teaching plans.
  - Any applicable idea under this MOU you suggest
- 1.3 Addenda to this document may identify specific projects, which will be undertaken within this overall PARTNERSHIP, and the details of their management. Further Memorandum of Understanding (MOU's) shall be developed for specific agreements based on the mutually agreed upon objectives and outcomes, at any time.
- 1.4 The purpose of this PARTNERSHIP is to outline an academic and management framework between the two parties, designed to promote





internationalization at both institutions. The parties do not intend to be legally bound to each other, and this PARTNERSHIP does not impose legal obligations on either party.

- 1.5 Both entities shall mutually decide and designate a nodal officer. The nodal officer will have responsibility for fulfilling the objectives of this agreement and also will carry out all activities mutually agreed by the parties.

## 2. Publicity and Advertising

The parties agree that each may publish or advertise the existence and nature of activity under this PARTNERSHIP. Nothing in this agreement shall be construed as confidential.

## 3. Duration of the PARTNERSHIP

- 3.1 This PARTNERSHIP will be effective upon signature by each University President for a period of three years, at which time it will be reviewed for possible renewal for another three-year period.
- 3.2 The parties may propose a mutually agreed upon modification to activities or arrangements under this PARTNERSHIP.
- 3.3 Either party may, with six months written notice, terminate the PARTNERSHIP in advance of its normal expiration or request the renegotiation of its conditions. Under such circumstances, staff or students shall be allowed to complete the activity under old conditions that have commenced an activity under the PARTNERSHIP.
- 3.4 Addenda to this document are an indispensable part of this PARTNERSHIP. The PARTNERSHIP is made in English.


